CALL TO ORDER

The meeting was called to order by the Director Human Resource and Administration Mr. Enock Ngulube

OPENING PRAYER

The opening prayer was given by the Marketer Mr. Simataa Mwale.

INTRODUCTIONS

All stakeholders present introduced themselves accordingly

CMTEM/02/09/24: DIRECTOR HUMAN RESOURCE AND ADMINISTRATION OPENING REMARKS

In his opening remarks the Director Human Resource and Administration welcomed everyone to the meeting and urged them to freely contribute during the deliberation on the way forward on street vending and welcomed submissions from the marketeers having said that he declared the meeting open.

CMTEM /03/09/24: SUBMISSION FROM STAKEHOLDERS

The Chairperson for Katambalala Mr Wilson Mwaza stated that the council concerns were marketeers concerned as well and that the process of moving street vendors was initiated after having the meeting

with Council Management. He went on to explain that it was also agreed that people selling merchandise at Katambalala would be provided with some space behind fire station. Unfortunately, the space were not adequately to accommodate all of them. Further, he mentioned that there was no business at Chileya market compared to the main market.

Other response from the Main Market Chairperson Mr. Edward Mwale, he welcomed the decision as well to move people from Katamalala and that as earlier discussed they were waiting for implementation as there was no sanity in the District.

CMTEM /04/09/24: THE WAYFORWARD

The Director Human Resource and Administration stated that the Authority was concerned with the traders trading along all the street and at Katambalala (chimweta) area as a high risk place. He added that the authority wanted to prevent accident which could result from people trading along the road at Katambalala if the motorist loses control. He also mention that it was not every ones wish / prayer to record / witness an accident happening from traders trading along the road while Council could prevent such from occurring by allocating them with trading spaces. Additionally, he mentioned that Council was not collecting revenue from traders trading from undesignated spaces yet they were making more sales than those in the market there by affecting council to provide services to the Traders such as waste management

CONCERNS

The Chairperson for Katambalala Mr Wilson Mwanza raised a concern that the allocation of traders trading at Katambalala was not done accordingly as agreed as people allocated were the people with stand already at the market.

CMTEM /05/09/24: PLENARY

In plenary the Director Human Resource and Administration said that the authority concern was to prevent every Petauke residents from losing life resulting from trading at a high risk place like Katambalala and that all of them would be accommodated as the Council is obligated to provide trading spaces.

After a lengthy deliberation, it was;

RESOLVED THAT:

i) all traders having stands at Chileya and Main Market but still Trading at Katambalala to move to their respective stands effective Friday 5th September, 2025.

ii) The Market Master and the market Chairperson for Chileya market to conduct a physical count and come up with a total number of vacant stands at Chileya market by Tuesday 10th September, 2024.

CMTCM/03/08/22: CLOSING REMARKS

In his closing remarks the Director Human Resource and Administration thanked everyone and argued traders not to bring new traders as it would pose a challenge to the local Authority to allocate them.

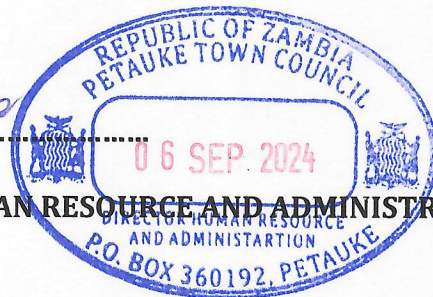
As there was no any other business to discuss on the agenda the meeting was declared closed after a prayer by the Chairlady Ms. Ruth Chali at 16: 42 hours.
